

This Web site, like most Web sites, uses Cookies to improve and optimize the user experience.

Below you will find detailed information about what cookies are, what type of cookies this website uses, how you can disable them in your browser and how to specifically block third party cookies.

1. What are Cookies?

Cookies are files that websites or applications install on a user's browser or device (smartphone, tablet, or connected television) during their browsing of the site pages or application, and serve to store information about their visit.

Like most sites on the Internet, this website uses cookies for:

Ensure that web pages can function properly. Store preferences, such as the language you have selected or the font size. Know the user's browsing experience. Collect anonymous statistical information, such as what pages the user has visited or how long the user has been on the website. The use of cookies makes it possible to optimise browsing, adapting the information and services offered to the interests of the user, in order to provide him with a better experience whenever he visits the website.

This website uses Cookies to function, adapt and facilitate the user's navigation as much as possible.

2. Cookies used on this website

MST Holding informs you that our website uses our own and third party cookies to measure and analyze the navigation of our users.

MST Holding uses two types of cookies on our website:

- **Technical Cookies:** Are those essential for the proper functioning of the site. They are normally generated when the user accesses or logs in to the website and are used to identify the user on the website.
- **Analysis Cookies:** These are those that are well treated by us or by third parties that allow us to quantify user access and thus carry out statistical analyses of the use of the website. In order to achieve this, your navigation on the MST Holding website is analysed in order to improve our functionalities. The third party application used by MST Holding is Google Analytics. Third party applications provide us with the service of measuring and analysing the audience of our web pages, downloading videos and documents, facilitating and monitoring the connection and publication of content between the MST Holding website and social networks such as Twitter, LinkedIn...

The information you obtain is related to the number of pages visited, language, social network in which our news is published, city or region to which the IP address from which it is accessed is assigned to, the number of new users, frequency, time and repetition of visits, browser and operator or type of terminal from which the visit is made.

They can also use this data to improve their own services and to offer services to other companies. You can find out about these other uses from the indicated link.

3. Disable the use of Cookies

If the user so wishes, it is possible to stop accepting browser Cookies, or to stop accepting the Cookies of a particular service.

All modern browsers allow you to change your cookie settings. These settings are usually found in the "Options" or "Preferences" of the browser menu.

Some functions and services may be disabled or behave differently than expected, such as, for example, staying identified, keeping the session open if you have identified yourself, or receiving information directed to your location, among others.

If you disable the use of cookies on this website, it is likely that you will no longer be able to access certain areas of the website or that the browsing experience on this website will be markedly degraded.

5. Updating the Cookies Policy

MST Holding can modify this Policy of cookies in function of legislative, regulatory requirements, or with the purpose of adapting this policy to the instructions dictated by the Spanish Agency of Protection of Information.
